Chartered Members receive special recognition with:</p> <ul style="list-style-type: none"><li>• A directorship on the Board of Directors, the company name displayed in AMCHAM's media packets;</li><li>• Being eligible to participate in the Special Purpose Committees that engage in advocacy on issues that may affect the specific business and social environment of the company (see our website for more details);</li><li>• Benefit from proprietary information as well as access to exclusive events, briefings, and meetings with prominent representatives of American, European, and international bodies and institutions;</li><li>• Recognition in AMCHAM's Newsletter (one time only);</li><li>• Free entry to all AMCHAM events (with the exception of paid lunches or dinners).</li></ul> <p>An initial capitalization fee of <b>EUR 2,500</b> is required via three annual installments of EUR 2,500 during each of the first 3 years, thereby confirming the firm's extensive commitment to community service and support. This will be followed starting the 4th year by an annual fee of <b>EUR 1,100</b>.</p>

	<p>Corporate Members are the backbone of AMCHAM Luxembourg. They are recognized as significant and active participants in Luxembourg and the Greater Region's business community. Businesses with <b>11+ employees</b> benefit from the support and networking activities of AMCHAM through:</p> <ul style="list-style-type: none"><li>• Being eligible to participate in the Special Purpose Committees that engage in advocacy on issues that may affect the specific business and social environment of the company;</li><li>• Recognition in AMCHAM's Newsletter (one-time only);</li><li>• Free participation in all AMCHAM events (with the exception of paid lunches or dinners) for all employees.</li></ul> <p>Annual fee is <b>EUR 850</b>.</p>

	<p>Small Business Members have the same basic rights as Corporate Members. The Small Business Members are start-ups or small independent businesses with 10 or fewer employees. Generally Small Businesses grow into full Corporate Membership as their business activities expand over time. 	<p>Companies or Independents with 3 employees or fewer who have been in existence for <b>more than 5 years</b> are stand-alone organizations and not subsidiaries of larger entities. The application requires proof of existence via the published Memorial announcement. This type of membership is offered by AMCHAM to encourage entrepreneurship and to help/support all such companies after the first 5 years after their creation has been published in the Luxembourg Memorial. Micro-companies enjoy all the rights and benefits of AMCHAM membership except the right to vote:</p> <ul style="list-style-type: none"><li>• Free entry to all AMCHAM events (with the exception of paid lunches or dinners) for all employees;</li><li>• Recognition in AMCHAM's Newsletter (one-time only).</li></ul> <p>Annual fee is <b>EUR 200</b>.</p>

The application requires proof of existence via the published Memorial announcement. This type of membership is offered by AMCHAM to encourage entrepreneurship and to help/support all such companies during the first 5 years after their creation has been published in the Luxembourg Memorial. Micro-companies enjoy all the rights and benefits of AMCHAM membership except the right to vote:</p> <ul style="list-style-type: none"><li>• Free entry to all AMCHAM events (with the exception of paid lunches or dinners) for all employees;</li><li>• Recognition in AMCHAM's Newsletter (one-time only).</li></ul> <p>Annual fee is <b>EUR 100</b>.</p>

	<p>Academic, Government, EU or Senior Membership category includes individuals who are either:</p> <ul style="list-style-type: none"><li>• Students, Professors, or researchers actively affiliated with an Academic Institution;</li><li>• Government, EU institution employees or officials;</li><li>• Individuals who are at least 60 years of age and not engaged in full-time employment.</li></ul> <p>Academic, Government, EU, and Senior members enjoy all the rights and benefits of AMCHAM membership except the right to vote. Annual fee is <b>EUR 100</b>.</p>

The fiscal year of the American Chamber of Commerce in Luxembourg starts on the first of January of each year. An Annual General Meeting is usually held within three months of the close of the fiscal year to renew the Board of Directors, review the previous year's performance and set goals for the new fiscal year. Membership is automatically renewed annually. A member wishing to resign must send notice in writing by post, fax or email. Notification of resignation must be received no later than the last day of the first month of the new membership period (31 January). If such notice of registration is not received, the member will remain on the membership list and be liable for payment of dues for that year.
